EVERY 30 MINUTES CONTROL OF THE WEIGHT AND OF THE DOSING OF THE FRAGRANCE. EVERY 1 HOUR TEST ON TWO SOAPS IN ORDER TO CHECK THE COLOUR, PRINTING, AND POSSIBLE ANOMALIES.

6. FURTHER INFORMATION

THE COMPOSITION OF THE FRAGRANCE IS CONFORM TO THE IFRA AND RIFM SPECIFICATIONS.

THE STABILITY TESTS GRANT THAT, AFTER 30 MONTHS, THERE ARE NO APPRECIABLE CHANGES COMPARED TO THE STANDARD CHEMICAL AND PHYSICAL SPECIFICATIONS.

ALL OUR PRODUCTS ARE MANUFACTURED IN THE FULL RESPECT OF THE NATIONAL AND EUROPEAN COMMUNITY LAWS ON THE COSMETIC PRODUCTS.

STOCKING CONDITIONS: FROM 10° C MAX 35° C. SINCE THE SOAP IS A PRODUCT CONTAINING MOISTURE THAT EVAPORATES WITH THE PASSING OF THE TIME THE FILM WE USE TO SHRINK THE PALLETS IS ONLY A PROTECTION DURING THE TRANSPORTATION. IN ORDER TO AVOID PROBLEMS OF MOULD WE KINDLY ADVISE TO TAKE AWAY THE FILM FROM THE PALLET AT THE ARRIVAL IN THE WAREHOUSE AND NOT TO LEAVE THE FILMED PALLET IN THE WAREHOUSE FOR LONG TIME SINCE THE PRODUCT DOES NOT HAVE THE NECESSARY VENTILATION.
